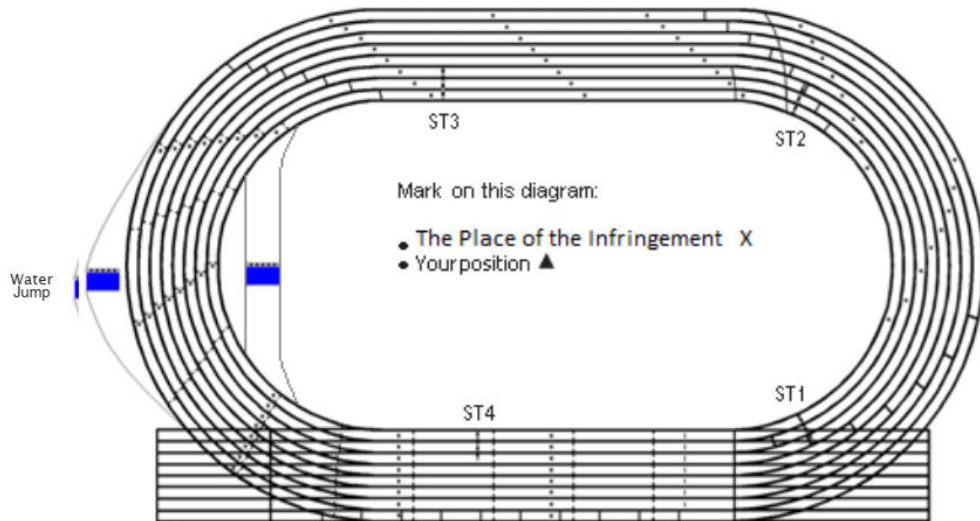

18.2	Pushed, obstructed or jostled competitor no..... so as to impede his/her progress. Deliberately <input type="checkbox"/> Accidental <input type="checkbox"/> Advantage gained? Yes / No
18.5	Ran / wheeled outside lane no into lane no..... for strides / metres
18.7	Broke from lane no..... for strides / metres before the break line
18.9	Athlete / Guide voluntarily stepped / rolled off the track for strides / metres on lap no.....and subsequently rejoined the race
Visually Impaired (T11-12)	
6.18	T11 athlete did not have eye cavities covered with gauze and / or not wearing opaque glasses and / or substitute

7.10	Athlete pushed / pulled / otherwise propelled by Guide in order to gain advantage

19.4	Athlete not in front of Guide when reaching finish line
Race Running Frame (T31-32) Wheelchair (T32 – 34 & T51 – 54)	
6.7	Athlete failed to display number on back of chair or side of race running frame.
6.9	Athlete failed to display numbers on helmet when required by LOC
6.22	No helmet worn by athlete
8.5	Athlete allowed urine to drain onto track
14.6	Part of lower limb fell to the ground during the event (not applicable to T32 competitors)
18.3	Means other than pushing on the wheels or push rims used to propel chair
18.4	Overtaking athlete cut in before achieving full clearance of chair being overtaken
Prostheses (T45 – 47 and T61 – 64)	
6.12	T61-64 Athlete did not complete race with lower limb prosthetic attached
6.14	T45-47 Athlete who chose to compete with upper limb prosthetic did not complete race with such device
Assistance to Athletes	
	Received assistance or coaching. Give details opposite
Athlete Misconduct	
	Any athlete acting in an unsporting or improper manner renders him/herself liable to disqualification. Give details opposite or on back of form. Note: If an athlete is disqualified during the competition, reference to the WPA rule infringement should be made in the result.
